Objectives for Quality:

- improve the organization, production standards and / or methodologies in order to raise production efficiency levels and reduce internal costs, making the best use of the resources allocated to business management;
- improve the sensitivity, collaborative spirit and attention of all staff towards quality aspects;
- create and maintain an internal environment that fully involves staff in the pursuit of objectives
- create a mutually beneficial relationship with suppliers, in order to improve, for both, the ability to create value;
- contribute to the material and professional development of company staff;
- promote the guarantee of an effective, efficient and ethical compliance with present (mandatory, contractual) and future requirements;
- contribute with its organization to the defense of the interests of the community;
- identify the present and future needs of the organization and of the markets it serves;
- interact with the best in the industry sector to identify opportunities for improvement

BAIONI CRUSHING PLANTS S.p.A. has sanctioned with the implementation of an Integrated Management System compliant with the UNI EN ISO 9001: 2015, UNI EN ISO 14001: 2005 standards, its commitment to protect its work, the environment and safety with ISO 45001: 2018.

The general principles that Top Management places at the basis of its environmental behavior are the following:

- Operate constantly in compliance with the applicable legislation and operational, environmental and occupational health and safety regulations and other signed requirements;
- Communicate and maintain external relations with all interested parties without foreclosures or limitations;
- Guarantee and implement the participation of employees and organizations that carry out activities on behalf of BAIONI CRUSHING PLANTS S.p.A.;
- Pursue the continuous improvement of its operational, safety and environmental performance, reducing, where technically possible and with economic consistency, any negative impact of its activities on the interested parties and undertaking to prevent any kind of negative impact;

- The identified risks are assessed with the aim of preventing and / or limiting events.

In line with the principles set out, the Top Management has the following general objectives:

- Maintain an effective Integrated Management System according to the requirements of the ISO 9000, ISO 14001, and ISO 45001: 2018 standards;
- Identify applicable legislation and maintain regulatory compliance;
- Keep under control and, where possible, reduce direct and indirect impacts, with particular reference to the consumption of energy, raw materials, emissions into the atmosphere and reduction of waste produced;
- Increase the awareness of its staff towards environmental issues, in particular with reference to the reduction of waste resources (water, energy, raw materials, etc.) and the correct management of waste;
- Activate a communication process to and from other interested parties, with particular attention to raising the awareness of its customers and suppliers.
- Prevent accidents, occupational diseases and damage to the health of workers, by committing to the continuous improvement of safety and health in the workplace;

To achieve these specific objectives, the Top Management undertakes to:

- Make adequate resources, economic means and skills available for the correct functioning of its Integrated Management System for the continuous improvement of its operational, environmental and safety performance;
- Periodically review the achievement of the intermediate goals set for the improvement objectives, so as to be able to verify their achievement.
- Involve and consult collaborators on issues relating to safety in the workplace, also through representatives for Health and Safety;

Lastly, the Top Management undertakes to:

- spread the same principles to interested parties, mainly to suppliers;
- actively involve the staff in the exercise of its Integrated Management System and in the continuous improvement process;
- review this document to verify its continued suitability.
